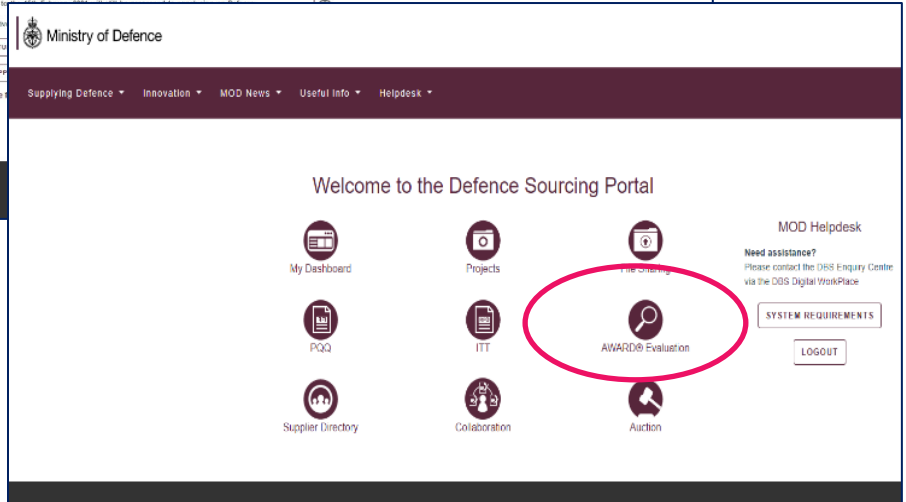


Defence Sourcing Portal and AWARD®

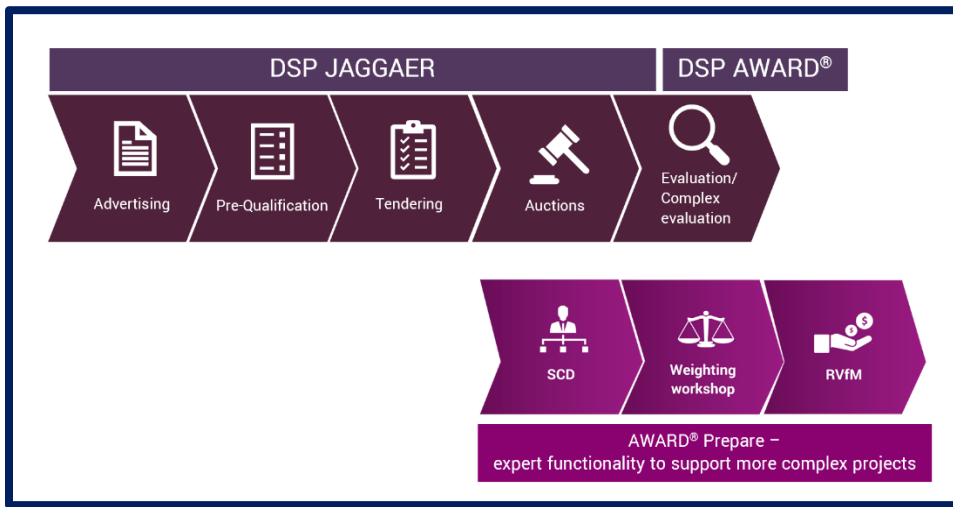


- Jaggaer supports the procurement process:
